ADDITIONALLY THE MISSION OPERATES THE HELP CENTER IN VAN NUYS THAT OFFERS EMERGENCY SERVICES TO HOMELESS INDIVIDUALS LIVING ON THE STREETS SUCH AS SHOWERS, HOT MEALS, CLEAN CLOTHES AND CASE MANAGEMENT. IN AGGREGATE, THE MISSION PROVIDES OVER 207,000 MEALS, 61,000 NIGHTS OF SHELTER AND 49,000 SHOWERS ANNUALLY. SHEPHERD'S HOUSE PROVIDES 90 DAYS OF CRISIS HOUSING FOR UP TO 15 HOMELESS FAMILIES AT ANY GIVEN TIME. UNDER THE COUNTY'S COORDINATED ENTRY SYSTEM (CES), HOTV PROVIDES HOUSING NAVIGATION AND RAPID REHOUSING REFERRAL SERVICES TO ELIGIBLE HOMELESS ADULT INDIVIDUALS. THE CORE WORK IS ASSISTING ELIGIBLE INDIVIDUALS WITH GETTING ENROLLED INTO

THRIFT STORE DONATIONS ARE ALSO USED TO PROVIDE CLOTHING FOR OUR SHOWER PROGRAMS AND HOUSEHOLD ITEMS FOR INDIVIDUALS AND FAMILIES MOVING INTO PERMANENT HOUSING.
